The church is in the midst of upgrading PCs. PCs don't qualify for Loveland Methodist Foundation money as they are not building related. They do qualify as a capital expense by definition. We can utilize 57th Street funds to support this purchase. We would like approval from the Church Council for \$6000 to purchase three tower computers and two laptops, along with cables, monitors and docking stations for the laptops.

This was a motion from a committee and didn't require a second. Discussion included the efficacy of 'towers,' and it was explained that they are more easily reparable than PCs. The breakdown of costs was requested and Judy received that information from Karen Lumpkin. The motion was amended to "...up to \$6000," and passed unanimously. Karen will purchase the computers on behalf of the church.

Discussion regarding the opportunity to rent space to Loveland Preschool.

Judy reported on a meeting she had with Rev Leslie after the last Council meeting. She expressed frustration that although Council approved the motion to investigate renting space in the building, CC members did not come forward to ask to be involved in the process. Judy asked Rev Leslie if it would be OK to form a small ad hoc committee to get

things moving. The committee would consist of two CC members, two Trustees and two church members at large. Rev Leslie agreed, and the following people agreed to participate: Joy Shaw and John Kindred from CC; Joanne Scheihing and Deb Tikka (Deb replaced Richard) from Trustees; Charlie Bouchard (who started the whole process) and Ann Kessler (who knows the building and has come forward with ideas). The pastors and Judy will join the committee as able/needed. In the midst of discussions, on Aug 23, Jen Kuzmich, Loveland Preschool Director (housed at Mountain View Presbyterian) posted on the Lovelanders FB website that they were losing their lease and needed to find a space to house their program. Charlie got in touch with Jen, and several different groups (various preschool people, ad hoc committee people, the pastors and others) have walked through the building. The space looked good to Jen and others, but we know that there is a lot to be done to make this happen.

After much discussion (notes on a separate page) the following motion by Joy Shaw, seconded by John Morgan passed unanimously:

"I move we authorize the investment of up to \$10,000 for architectural/engineering work to establish the feasibility of a preschool remodel project and estimated costs based upon the information provided by the Ad Hoc Committee."

Jen Kuzmich, LPS Director will join us at 6:30 to answer questions.

 - *I believe we have previously discussed this, but just in case, I would like a few minutes of the mini retreat to discuss the conversations that the mission insight task force has undertaken.

Attached is the Quick Insight form that summarizes the information from mission insight. I will not be going over all of it. I will summarize the summary and point out other important findings from the taskforce

Based on Mission Insight, the largest population group in Loveland is the 'digitally savvy' of which Matthew is a member. Second largest is the 'young parent' group. Neither of these groups are well-represented at our church. It is important to look at these top segments and see how to minister to them. We need to know who is in the building now, and who is in the community around the church (~five-mile radius). We can go back as often as needed to reexamine the information from MI.

Regarding Readiness 360 ~ this determines how ready the congregation is to interact with new ideas and new ministries; are we ready to be the church in new ways?

Keith made a motion seconded by John K: FUMC should support a preschool in our building as part of our ministry. Passed unanimously.

 - o Maybe the preschool (if it works out) will be the antidote and will revitalize the church.
