Motion by John on behalf of SPR: Move to hire Technical Framework in Ft Collins to serve as FUMC's IT support. Passed unanimously.

Discussion:

- Chris Munger will start immediately.
- The retainer is \$1800/year and \$150/month. 'House calls' will be \$100/hour.
- Chris will do routine updating, backup system monitors, remote monitoring, keeping backups for our systems.

Children's coordinator update: motion by John on behalf of SPR to approve the Family Programming Coordinator job description. Passed unanimously. John reminded us that although we have very few children in Sundy school now, we need to plan for more!

Finance discussion ~ Rick Tessean sent an email in response to the Oct 7 minutes that stated, "The remodel will not be paid for from the Foundation, but with proceeds from the property sale." Rick said the it would be paid for from the Foundation.

- Because the Foundation is currently and endowed foundation, we are limited in the amount of money we can draw each year. We can use funds from the property sale and repay the Foundation when funds are available.
- We could consider using a CD worth ~ 40,000 that is coming due, although money from CDs is not restricted to capital expense. We may need that money for operating expenses at some point.
- The church does have a reserve fund that would cover two months' expenses if that should become necessary. Trustees Richard Kittel

Discussion items

- Charge conference approved the motion '...that this Charge Conference approve plans for FUMC Loveland to
 move forward to lease space to Loveland Preschool beginning in the 2025-26 school year. These plans include
 naming Rob Proctor as project manager and John Kindred, Pete Shaw, Rich Stiverson and Judy Stout as
 members of the project committee.'
- From the District Building and Relocation Committee to Rev Leslie: Leslie: The vote is complete, and the District Board has granted its consent for First UMC Loveland to lease four rooms of its church property to the Loveland Preschool in accordance with the documentation provided by the church for the District Board's review and consideration. Between the two organizations we got it done before the 01 November deadline. Good luck with the venture.

Regarding the renovations, as the cost is less than 25% of the value of the building and a mortgage is not required, the District Board does not need to be involved in the renovation project. If the parameters change regarding the renovations, please let me know. JR

- Judy spoke to Jim Webb, Pastor Head of Staff at MVPC to get his take on LPS. He has been there for 20 of their 60 years, his children attended and his comments were generally positive:
 - o They pay rent on time, are cooperative, compliant, reasonable with requests (asking for extra space like Christmas brunch).
 - o Their board changes every year; sometimes they are pleasant to work with, sometimes less so.
 - The biggest issue was the all-day scenario. When they are using MV space, they don't have access. After Covid they asked for an afternoon session, but didn't have enough enrollment. They tried again, but MV had rebounded and they needed their space for their programs.
 - Another question MV wrestled with was: how does a church host a *government-sponsored program with finding? With money usually comes strings. MV was concerned that the government might impose restrictions on the church. *In CO, all children in their year before kindergarten can register for at least 15 hours of funding per week towards a high-quality preschool of their choice. I asked if there were any red flags, and Jim said no,
- Direction for ministry use in Coy Hall
 - o Does Council plan future use of that space to be somewhat as it is now, with the ability to close off or open up the two side meeting rooms?
 - o Or will E and/or W Coy become a permanent meeting/gathering space off the larger Coy, requiring fixed walls and, possibly, a door access directly into Coy?
- Update on mission/ministry statement

John Kindred, Barry Wehrle, and Matthew Utley have been meeting about updating our mission statement. As a group we discussed how our statement should be brief, yet memorable. We wanted our mission statement to be inclusive to all people. As requested, we also took inspiration from Washington Park UMC's Mission statement. Here is what we came up with.

"Loveland First United Methodist Church, a community of faith, accepts people as they are and seeks to help them move toward an abundant life. We do this by living the teachings of Jesus Christ: love, peace with justice, mission to others, and hope while striving to live in harmony with all of God's creation."

We invite further conversation around this statement.
